Individuals and companies, both for profit and non-profit, who participated in the 2025 Sanders County Fair & PRCA Rodeo, are being provided a "Commercial or Non-Profit Vendor Space Reservation Form" to facilitate your participation in the 2026 Fair. A map of the Vendor's Midway (not to scale) is included and depicts the available vendor spaces. Please note that I changed some places for some vendors and have re-numbered most of the spots. Please complete the attached contract in its entirety, specifying what products you will be selling.

Please return the completed contract, along with your payment in full, **no later than June 1, 2026**. Spaces not paid for at that time will be released to other vendors on our waiting list. There are **No Exceptions** to this Fair Commission Rule. **Vendors may cancel their space reservation and receive a full refund up until July 20, 2026. If you cancel after this date, there will be no refund issued.**

Parking: If your vehicle will fit within your leased space, and stays parked for the duration of the entire fair, there will be no parking fee. Commercial vendors will be allotted One (1) free weekly parking permit; however, if you have additional vehicles, you will need to pay a daily parking fee or your may purchase an additional weekly parking permit, which covers the entire week of the fair. The fair week runs from Thursday September 3rd through Sunday September 6, 2026.

Vendors are required to be set up no later than six (6:00 pm) on Wednesday September 2, 2026. You may also set up prior to this time if you desire with approval from the Fairgrounds Manager. The arena events will begin on Thursday September 2nd with a PRCA Rodeo Performance and prior to that time, most activities involve open class and 4-H entries being brought in to the fairgrounds, being displayed, and being judged.

There will be <u>NO</u> driving on the grounds at any time during the Fair dates (Thursday September 3rd – Sunday September 6th) due to safety reasons... If you choose to remove your vendor items after hours (8:00 pm) on Sunday, you <u>must</u> do so by hand or by cart.

***Please note that there are No Dogs allowed on the Fairgrounds with the exception of Service Dogs. Your dog may be on a leash at your camper or at your vehicle <u>only</u>.

The Sanders County Fair provides roaming security patrols throughout the night, but does not guarantee the security of your vendor space or its contents. Safeguarding your products are your responsibility.

Weapons, such as guns, knives, etc., and products of an illegal, immoral or pornographic nature are prohibited, as are fake cigarettes. This is a family oriented fair and such products are not welcome. We will remain a family friendly event and if we have issues with any vendors, you will be asked to leave without a refund and will not be able to return to any future events. Please abide by these guidelines...
